Sujata Mody's book sheds light on the interactions between Dwivedi and his supporters and detractors and shows how Dwivedi's responses to challenges were pragmatic and strategically varied. *The Making of Modern Hindi* presents Dwivedi as a dynamic and influential arbiter of literary modernity whose exchanges with competing authorities are an important piece in the history of Hindi literature.
